A RESOLUTION OF NEW FREEDOM BOROUGH,  
YORK COUNTY, PENNSYLVANIA EXTENDING A CONTRACT  
FOR THE COLLECTION AND DISPOSAL OF REFUSE & RECYCLING  
IN NEW FREEDOM BOROUGH

WHEREAS, the Borough advertised and invited bids for the grant of a contract for the collection and disposal of refuse and recycling beginning January 1, 2019 and ending December 31, 2021; and

WHEREAS, the Borough received bids from potential contractors for the above project; and

WHEREAS, the Borough determined, from the bids and investigation of the responsibility of the bidders, an appropriate party to be granted the contract; and

WHEREAS, on December 13, 2018 the Borough executed a contract with Penn Waste, Inc.; and

WHEREAS, Section 5 of said contract, allows the Option to Renew; and

WHEREAS, Penn Waste has provided the Borough with a one (1) year extension price of \$49,004.85 per month; and

WHEREAS, all sections of the December 13, 2018 contract shall continue to apply for the period of January 1, 2022 to December 31, 2022.


NOW, THEREFORE, BE IT RESOLVED that Penn Waste Inc. be awarded the one (1) year extension of the current contract for the collection and disposal of refuse & recycling in the Borough of New Freedom, York County, Pennsylvania at a cost of \$49,004.85 per month.

  - a. CDL Driver Shortage and Current Labor Crisis – resulting in labor rates to increase far above inflation.

  - c. Insurance – Premiums continue to increase in the 10-20% range annually.
2. Continuity of Service – This extension would allow for no disruption of service to the residents of New Freedom Borough.
