WHEREAS, the Borough has received bids from potential contractors for the above project; and


WHEREAS, the Borough has determined, from the bids and investigation of the responsibility of the bidders, an appropriate party to be granted the contract; and

WHEREAS, by this Resolution, the Borough awards a contract under the terms and conditions spelled out in the licensing documents, as defined in the contract specifications.

NOW, THEREFORE, BE IT RESOLVED that Penn Waste Inc be awarded a contract for the collection and disposal of refuse & recycling under the terms and conditions of the licensing documents, as defined in the Specifications for Collection and Disposal of Refuse & Recycling in the Borough of New Freedom York County, Pennsylvania dated October 17, 2022. The President of Borough Council and the Borough Secretary are hereby authorized to sign the New Freedom Borough Collection and Disposal of Refuse & Recycling Contract Award on behalf of the Borough.


