**INTERGOVERNMENTAL AGREEMENT:** No update.

**FARMER'S MARKET:** No Farmer's Market this season. Tabled until Fall of 2023. It was suggested that we may want to consider starting to look for a program director.

**VETERAN'S DAY:** Our Veterans Day dinner will be held on November 9, 2023 in the Community Center from 6-9 PM. Donations are being solicited and are coming in. M. Michels made a motion that we spend no more than \$500.00 on the event. S. Boyle seconded, motion carried.
